

## Input Data for Online submission of eForm 16 to ICA

A foreigner who has gain admission for a course of study in a Foreign School System needs to apply for a Student Pass if he/she is not a DEP holder.

After the School has Registered the Foreign Student with a SOLAR+ Application number with ICA the Student should go online to submit the required information. Some FSS schools and colleges will perform this function on behalf of the foreign student. If the student is required to do online submission himself/herself and is unfamiliar with the online process our Consultancy can assist. A service fee is payable. We can also arrange for the medical examination which will be required prior to STP collection.
